Jazz History October 13, 20 @ 12:00 pm

Session 1: Contributions of African-American Music and Musicians to American and World Culture

Black music has been accepted, loved, and imitated throughout the world. This program includes recorded music and describes en-

counters with black music in the United States, Europe, Asia, and elsewhere around the globe. It explores how popular culture has been shaped to a great degree by black music and musicians.

Session 2: American Jazz History

This presentation, using video and recorded music, provides a cursory look at the major innovators, musical stylists, and representative tunes that define the many periods and styles of jazz. The speaker will discuss the blues, ragtime and other precursors of jazz, big bands and swing, the rise of modern jazz, jazz-rock fusion, the bebop renaissance, and the future of jazz.

This course is led by:

William "Ted" McDaniel, Professor Emeritus of African-American Music at the Ohio State University. A specialist in African-

American music and jazz performance, he is noted for his analysis of the music of John Coltrane and Charlie Parker. He has published several works on black music and more than 300 music arrangements.

Session 1: The Truth About Bats

Did you know that Ohio has an official Bat

Week? We're thrilled about this celebration because more than anything, bats need love! In this presentation, you'll learn three reasons why bats are rock stars, and what it takes to be a caregiver for injured and orphaned bats. You're guaranteed to be amazed at these flying mammals that make up nearly one fifth of all mammal species on our planet. Bats live almost everywhere on Earth, so no matter where you live, it's almost certain that there are bats living near you.

Session 2: Gimme Shelter: Rescue, Rehabilitation, and Why It Matters

Over 6,500 injured, orphaned, displaced and ill wild animals enter the Ohio Wildlife Center Hospital each year. We are one of a global network of wildlife rescue centers and sanctuaries across the world that care for hundreds of thousands of wild animals – victims of the illegal wildlife trade, habitat destruction and injuries often caused by the activities of people. From chimpanzees in Sierra Leone, West Africa, to great-horned owls in Ohio, rescue and rehabilitation centers have a unique and important role to play in wildlife conservation and in influencing the way people relate to animals.

Rebecca is the Conservation Liaison for the Ohio Wildlife Center. She joined the OWC team after working at the Columbus Zoo as the Field Conservation Officer. Rebecca serves on the board of directors for the Pan African Sanctuary Alliance, Friends of Bonobos, and the Center for Conservation Peacebuilding based in D.C. She completed the Climate Reality Project training with former Vice President Al Gore, and is certified to present on the topic of climate change. She is a member of the Ohio Bat Working Group. DNA testing: what is all the fuss about?

Week 1: What is consumer direct DNA testing?

Learn how DNA testing can help you find potential matches and break down walls in your family history research, Learn about three types of DNA testing—autosomal, mitochondrial, and y DNA tests. Determine which type of test you should take from the five common testing companies—Ancestry DNA, Family Tree DNA, 23andMe, My Heritage, and Living DNA. Find out how the Human Genome Project made tests and

health information affordable. Discussions will include adoption, unknown parentage, donors, privacy, secrets, law enforcement, and risks.

Misconceptions about ethnicity. What can your ethnicity charts tell you?

What can the tests <u>not</u> tell you? And how do testing companies determine where you come from?

Week 2: Genealogical DNA testing for beginners

Learn how to determine genetic relationships in different types of tests. If you have results, learn how to make sense of your matches and get the most out of the five common testing companies - Ancestry DNA, Family Tree DNA, 23andMe, My Heritage, and Living DNA.

Understanding Your DNA Health Reports: Do you have thealth report from 23andMoor Promethease?

Learn how to analyze magnitude, position and frequency. A "tendency toward" something is not a "diagnosis of." Find out what the Human Genome Project has discovered about specific genetically linked traits and diseases. What can the tests tell you and what can they <u>not</u> tell you. Discover how to talk to your doctor about the results.

Week 3: I have my DNA results, now what?

So you have your DNA results. Now what? DNA for genealogy can be overwhelming. Learn the basics of genetic genealogy, important vocabulary, and some valuable resources. Hear some basics about mitochondrial DNA tests, y-tests, and autosomal tests. Learn about common third-party tools and sites to help you understand your autosomal matches. How do you organize your matches to make the most of the

information? Learn how to make your matches work for you.

A Case Study: A Mystery First Cousin

Learn the methodology and steps needed to uncover who a person is in your autosomal match list.

Week 4: What can you learn from a set of siblings?

Children are a subset of their parents' DNA. Non-identical siblings inherit about 50% from mom and 50% from dad, but not the same mixture of DNA. Learn about genetic diversity among siblings and how this diversity can help your research.

Strategies to Identify Your DNA Matches

Learn how to use your matches and clustering tools from each company to build a master list of how each match is related to you! Learn to take advantage of inferred matches of your siblings to add more depth and data to your list. Develop a plan for identifying each first, second, and third cousin match in your match list.

University in 1994 with a BS in Psychology. He began his law enforcement career in 1995 as a Jailer with the Marion County Sheriff's Office and then a Deputy Sheriff. He joined the Marion City Police Department in

January of 1999 and was promoted to his current rank of Lieutenant in May of 2003.

While at the Police Department, Lt. Brown has been a patrol officer, patrol supervisor, field training officer, crisis intervention team and sexual assault response team member, hostage negotiator, evidence technician, police instructor and supervisor of the major crime investigations unit. Currently, he is the MPACT Coordinator responsible for community outreach, crime prevention, the school resource officers, and the code enforcement officer amongst other duties.

He is still a resident of Marion where he and his wife have raised their two children. In giving back to his community for the benefit of all. He is a past board member of the United Way, held positions with the Boy Scouts of America and had a number of scouts obtain the rank of Eagle while he was scoutmaster of Troop 50.
